3. **The company stamp** for registration and documentation purposes.”

Delivery of Bids: Completed bids sealed in one envelope clearly with the Package name.

Important notes:

- a) Bids shall be submitted in hard copy at the location and address as described in the bidding document. Electronic submission of the bids **will NOT** be accepted.
- b) Bidders are required to submit bids in person or courier on or before the deadline: **05/May/2026 at 10:00 AM**, together with a Bid Security in the amount as described in the above ITT bidding information sheet, valid for a minimum of 4 months effective from the date of Bid Opening. (Validity period)
- c) The bids will be opened on the **05/May/2026 at 10:00 AM** in the presence of the bidders' designated representatives who chooses to attend.
- d) A pre-bid meeting shall be held on **(N/A)** at AKHS, A.
- e) The Client will NOT consider any bids that arrive after the deadline for submission of bids. Any bids received after the deadline for submission of bids shall be declared late, rejected, and returned unopened to the bidder.
- f) The Client will not be responsible for any cost or expenses incurred by Bidders in connection with the preparation and delivery of their bids.
