- **Vendors must acknowledge that payments will be through bank transfer. If bank transfer is not acceptable, then please do not submit a quotation.**
- The potential vendors should accept tax withholding based in Afghanistan Tax Law.
- All the cost should be stated in Local currency (AFN).

Selection Criteria:
