#### Animals Specification:

Type: Bull/Cow (NO DAIRY COWS ARE ACCEPTED), the preference will be given to bull not cow.

Age: 2 Years old with visible Minimum two (2)-Maximum Six (6) Teeth.

KG: The animal should give an average net meat of 85 Kg equivalent to 17 fresh meat packs of 5 kg.

The supplier must complete the number of animals (Bull) as well as number of fresh meat packs.

For completion of meat packs supplier must provide same specification of animals (bull) as per mentioned above

Major Requirements:

Animal should not have any physical defects, nor pregnant Cow i.e., blindness, missing/ broken limb, and damaged horns. The Animals should be healthy, active, and fit for Qurbani as per Shariah law.

- Bidders are welcome to provide quotations for all covering provinces but partial participation against one province or multiple will also be acceptable.
- animals should be slaughtered for each covering province as per above animals' (bull/cow) specifications. It is also mandatory for the supplier to gather the total number of animals allocated for each province **5** days before the Eid.
- As priced above, supplier is required to prepare one slaughterhouse as per provided specifications, two teams of six butchers and 10 supporting labors each for two shifts of (day and night), one 40 ft chiller (powered on at least 36 hours on three days of Eid), a mobile or fixed cold storage within each slaughterhouse with a capacity of preserving at least 4000 meat packs.

IRW team will start inspecting and physical verification of animals from 5 days before the Eid and continue till the 1<sup>st</sup> day of the Eid. Supplier is required to gather and make animals and their proper stable for rearing and verification available as per the given timeline.

#### Timeframe for Supplying Contracted Quantities of Animals and Meat Packs

- 1- Animals/Bulls: For any given province, the supplier is obligated to gather and make total allocated animals available before **5 days from Eid**.
- 2- Shade/facility for keeping animals and processing the physical inspection shall be rented and made available by the supplier of any given province at least **5 days before Eid**.
- 3- Inspection Timeframe: IRW team will start inspecting and physical verification of animals from 5

#### days to Eid and continue till 1 day to Eid.

- 4- Slaughterhouse: Suppliers are required to prepare one slaughterhouse as per provided specifications at least 5 to 3 days before Eid as IRAF's team will inspect and approve the slaughterhouses in each province. Each slaughterhouse must be equipped with a fixed (40 ft chiller) cold storage within each slaughterhouse with a capacity of preserving at least 4000 meat packs of 5kgs each.
- 5- **Butchering Team:** Two teams of six butchers and 10 supporting labors each for two shifts of (day and night) for each province should be hired and made available for IRAF's team at least 3 days before Eid so that they are properly oriented and trained on Slaughtering Job.
- 6- **Transportation:** At least **3 Days before Eid**, Supplier must make One 40 ft chiller (with a capacity of refrigeration at least 25MTs of packed fresh meat and transport it to the distribution points and powered on at least 36 hours of 3 Eid days)

#### General Terms & Conditions

#### 3.1. General

- Supplier shall provide bid security amounting 5% (in the name of Islamic Relief Worldwide) in the form of bank guarantee along with tender pack, the bank guarantee will be returned to unsuccessful bidders after decision of tender. Tender without bank guarantee will not be considered.
- Quoted prices for the above items shall be inclusive of all kinds of Govt. taxes and duties as per prevailing Tax Laws of Govt. of Afghanistan, Transportation, and Custom Clearance and port taxes (if any)
- All prices must be quoted in AFN (Afghani currency)
- Supplier will be responsible for animal fodder, vaccinations, and care during animals keeping period.
- Supplier will be responsible for slaughtering, skinning, cutting, and packing of meat in food graded (transparent) bags with IR Logo, refrigeration in the time between slaughtering and distribution and transportation (Cold Chain) of packed meat to mentioned areas.
- Supplier will be responsible for proper cleanliness and hygiene of animal keeping and slaughtering area along with proper waste disposal of animal waste after slaughtering, skinning, cutting, and packing.
- IRW team will provide an orientation to all butchering teams before Eid and Supplier and the mentioned teams are obligated to follow the provided guideline at the orientation session.
- Supplier will be responsible for providing any needed good quality and enough quantity of tools, equipment and facilities needed within the slaughterhouse to carry on the tasks of sacrificing, skinning, cutting, packing, keeping fresh, weighing, transportation and distributing.
- Any damage, loss, theft, demurrage, and degradation of meat quality before delivery of meat pack at destination will be the responsibility of supplier.
- IRW shall have the right to award the contract as a whole or provincial wise.
- Withholding tax as per government prevailing rates shall be deducted at the time of payment.
- It is made clear to supplier(s) that between 20 to 30 percent increase in number of allocated bulls to be sacrificed in each province is foreseeable and supplier(s) have ensured IRW that they have done the preparation for that foreseeable increase as well.

- Payment shall be made in the form of cross cheque, bank transfer within 21 working days after execution of order and subsequent submission and acceptance of the invoice to the Islamic Relief (Afghanistan).
- Islamic Relief reserves the right to reject any or all quotations without assigning any reason thereof.
- In the event of selection, the supplier will be responsible for submitting 5% performance security in the form of a bank guarantee of the total contract value.
- The average clean meat produced from one animal must be 85 kg.
- Supplier is responsible to complete quantity of animals as contracted and will make sure to produce good quality clean meat of 17 packs (5kg per pack) from each animal. In case more than 17 packs of 5kg produced from one animal the extra meat or pack will also be given to IRW. In case one animal produces less than 17 kg, supplier shall slaughter additional animals with same specification (as per sharia) to complete 17 meat packs for IRW. The weight of one meat pack must be 5kg.

#### **3.2.** Bid Submission Requirements

- Documentary evidence of similar project executed in providing living animals and meats in last five years i.e., copies of Purchase order and agreement.

#### 3.3. Validity of Bid

• Bids shall remain valid for at least 90 days from the date of submission. If the last date falls on a holiday, the validity shall be extended to the next working day of the Company thereafter.
