Subject: Consultancy Services for Conducting Refresher Training on GIS and Remote Syncing

# 1. The Organization

Afghanaid is a British humanitarian and development organisation operating in Afghanistan. For close to forty years we have worked with millions of deprived, excluded and vulnerable families in some of the poorest and most remote communities in Afghanistan. We build basic services, improve livelihoods, and strengthen the rights of women and children, help communities protect against natural disasters and adapt to climate change, and respond to humanitarian emergencies.

Our community-led approach gives ordinary Afghans a voice in their own development, making them active participants in shaping the future of their country. With our years of experience, our majority Afghan team, and our deep understanding of local, cultural and ethnic issues, we have earned great trust and respect among the communities we work alongside. This has allowed us to gain access to some of the most underserved areas of the country.

#### THE OVERALL OBJECTIVE OF THE CONSULTANCY

The purpose of this Consultancy is to provide 5 full days of refresher training on GIS, basic of QGIS and remote syncing to 14 Afghanaid Staff; building the capacity of the staff, particularly the M&E staff to contribute to the success of the Afghanaid projects.

The focus of the training will be on the adult learning methodology and techniques. The consultant shall use interactive, participatory and collaborative approaches in delivering of the training. And provide tips on how to use the methods, techniques and principles for using GIS and remote syncing in different projects.

#### **Service Provider's Deliverables**

1. Develop a training manual in English including at least below modules:



- Basic introduction of GIS and QGIS
- Basic introduction of Remote sensing and vegetation monitoring
- Installation of GIS and QGIS in all Participant devices
- Creating GIS and QGIS map and map visualization
- Exporting data from CSV and excel to ArcGIS
- Working with Vector and Raster Data Layers in ArcGIS
- Basic and Advanced Symbology and Definition query
- Clipping raster and vector files and Creating Buffer
- Intersect Union Merge Dissolve
- Query builder and Map localization
- Geo referencing and data frame map
- Hydrology, data management and KML, KMZ and GIS shape file analysis
- Bringing GPS data into ArcGIS environment
- Processing GPS data using ArcGIS
- Digital Elevation Model (DEM) Surface Analysis
- Hydrological Analysis and watershed boundary identification
- Vegetation monitoring and Calculate Normalized Difference Vegetation Index (NDVI)
- Application of GIS in the field of Hydrology modelling, Surface, land cover, watershed drainage and land use using GIS
- Hydrology: Watershed Delineation and watershed selection, boundary confirmation, water flow direction, flow accumulation etc.
- 2. Deliver a minimum 5-day Training in Dari (Pashto) to Afghanaid team covering all above topics.



- 3. Prepare a complete report on the assignments in English including identification of 3-4 training participants to become GIS + Remote sensing trainer.
- 4. Record the training practical practices in video and share with the participants

#### **DATE AND TIME**

The training schedules for 6 hours per day (9 am to 3 pm, including one-hour lunch break) for 5 working days starting from October 16<sup>th</sup> and will complete on October 20<sup>th</sup> 2022.

#### **V**ENUE

The training will take place in the Afghanaid Head Office in Kabul province.

The payment will be done once the assignment is successfully completed and the service is delivered.
