شرطنامه Terms and Condition

Warranty: the installation training of medical equipment is on supplier, and supplier should provide 18 months warranty.  
Payment: The payment will be transferred 100% to your company's bank account after the goods receipt, inspected, quality checked and accepted.  
Bank Guarantee: Supplier will provide an used microscope instead of bank guarantee, if supplier will not deliver the ordered items on due date, the used microscope will not be returned to Supplier and included Nangarhar FHF project's asset.  
Installation and training: supplier has to install and provide training to the end users for all quoted items.  
Penalty: For each delayed day in performing the contract obligations a specific penalty which is 0.1% of the total contract value will applied to the supplier's payments.  
Tax: 2% tax amount will be deducted from the total cost of the bid price from registered suppliers with AISA or MOC & 7% from unregistered suppliers as Afghanistan government tax law.  
Delivery Location: All goods to be delivered to HN TPO office in Kabul Office no later than specified period from the date of signing of purchase order.  
Delivery Time: If the items are not delivered according to the delivery time, HNTPO has the rights to cancel the purchase order and the company will be black-listed with HNTPO for future business.
