As a result of this RFQ, MHI anticipates issuing a basic ordering agreement (BOA) – or possibly multiple BOAs – to establish specific pricing levels and parameters to order the needed goods. This will allow MHI to issue specific purchase orders, on an as-needed basis, for the procurement of materials and equipment for wells in Khost and Laghman provinces.

Introduction

Muslim Hands International – MHI is an International Relief and Development NGO, established in the United Kingdom in 1993 with the objective of providing relief and emergency services and long term sustainable development projects in a cultural, ethical, effective, efficient and transparent manner. Muslim Hands works both directly and with partners in over 50 countries worldwide carrying out short and long-term projects in emergency relief, Health, WASH, Education, Protection, shelter, safe water, and TVET programing and a particular intervention of Advocacy and Peace in Afghanistan only. Muslim Hands International has been awarded Investor in People (2000, 2004 & 2007) and also been accredited with Quality Management Systems Standard ISO 9001:2000. The organization is also a signatory to the International Federation of the Red Cross and Red Crescent Movement, and various NGOs in Disaster Relief and the main sources of funding of the organization are individual donors, trusts, institutions and DFID.

MHI shall not be responsible for any costs associated with a Supplier's preparation and submission of a quotation, regardless of the outcome or the manner of conducting the selection process.

Supplier Code of Conduct, Fraud, Corruption,

All prospective suppliers must read the MHI's Code of Conduct and acknowledge that it provides the minimum standards expected of suppliers to the MHI. The Code of Conduct, which includes **principles on labour, human rights, environment and ethical conduct** may be found at MHI website.

Moreover, MHI strictly enforces a policy of zero tolerance on proscribed practices, including fraud, corruption, collusion, unethical or unprofessional practices, and obstruction of MHI vendors and requires all bidders/vendors to observe the highest standard of ethics during the procurement process and contract implementation.
