Roots of Peace (ROP) is a humanitarian organization whose mission is to rid the world of landmines and other remnants of war by transforming toxic minefields into thriving farmland and communities through a focus on sustainable, organic farming practices. Roots of Peace implementing of pillar 2 (Community Livelihoods and Local Economic Activities) of the ABADEI project. The UNDP launched a crisis response initiative that will contribute to the prevention of a humanitarian catastrophe and the breakdown of the country's economy. The proposed activities will support the most vulnerable populations and prevent the collapse of micro businesses in the target provinces.

The purpose of this assignment is to support UNDP Afghanistan Country Office with the implementation of the Emergency Support for Community Resilience and Livelihoods Recovery Project Activity under Pillar 2 "Pillar (2): Community livelihoods and local economic activities" of ABADEI Project in 27 districts of five provinces (Badghis, Balkh, Farah, Laghman and Nangarhar) to address immediate livelihood needs of the most vulnerable population through community-based interventions to foster resilience and strengthen human security.

A. INSTRUCTION TO BIDDERS

- 1. The supplier should be a legal registered company.
- 2. The quotation must include the taxes as per income tax law. ROP-ABADEI -will not accept any additional taxes or changes to the awarded entity after an award is made.
- 3. According to income tax law, ROP-ABADEI will withhold 2% tax of the gross amount from provider who has valid registration license and 7% tax from those who don't have registration licenses.
- 4. No advance payment will be made.
- 5. Payments will be made to the provider by bank transfer, ROP-ABADEI will pay the provider in accordance with the payment schedules as stipulated in the Purchase order agreement within 30 days of submission of an acceptable invoice by the provider and ROP-ABADEI acceptance of the service.
- 6. Incomplete and non-compliant offers will not be considered.
- 7. The supplier must provide the one-year financial audit report.
- 8. The supplier must provide two similar contracts.
- 9. The supplier must provide 3 references including name and address of the company, contact name, phone and official email address, details of service provided, value of contract and duration of contract.
- 10. The vehicles are required for the operation of ABADEI project in targeted districts of Nangarhar, Laghman, Balkh, Farah, Badghis and Kabul provinces.
- 11. The vehicles should be Afghanistan hand side.
- 12. The supplier must provide expert drivers.
- 13. ROP will award the contract to only one Service Provider

1- Submission of offers

Submit signed, dated, and stamped quotations in this RFQ format with your offers to designated Procurement team before deadline specified in this solicitation. The subject line must be the RFQ#, (RFQ-ABADEI-2021-004 failure to adhere this instruction may lead to disqualification of a quotation from evaluation.

Please note that all quotations must be submitted in English.

Best offer proposals are requested. It is anticipated that a contract will be awarded solely on the basis of the original offers received. However, ROP-ABADEI reserves the right to conduct discussions, negotiations and/or request clarifications prior to awarding a contract.

2- Offer Format

Offerors are required to format their submissions in accordance with the instructions and requirements described in this RFQ. Failure to adhere to these instructions or requirements may lead to disqualification of a quotation from evaluation.

3- Questions on the RFQ

- 1. Offerors are welcome to seek clarifications or ask questions on the technical and administrative aspects of this RFO
- 2. All questions or requests for clarification must be in English.
- 3. Questions or requests for clarification should be submitted in writing by email only, by the deadline, and to the email address stated on the cover page of the RFQ.
- 4. Offerors should be aware that their responses to questions or requests for clarification may be shared with other Offerors.
- 5. Any verbal information received from employees of ROP-ABADEI the Beneficiary or any other entity should not be considered as an official response to any questions regarding this RFQ.

4- Pricing

- 1. All prices presented in a quotation should be firm, fixed, and all-inclusive. No additional sums will be payable for any change or escalation in the cost of materials, equipment, packaging or labor, warranty-related costs and charges, and any and all other costs and charges of whatever description or amount in connection with, necessary for, or resulting from the Offerors' required performance.
- Prices must include all taxes, duties, customs clearance, and other expenses required by the Country in which the factory or assembly works. ROP CBARD -ABADEI will not accept any additional taxes or changes after any resulting award.

5- Sources and Nationality

The vendor may not supply any goods or services manufactured in or shipped from the following countries: Burma (Myanmar), Cuba, Iran, North Korea, Sudan, Syria.

Prohibited telecommunications and security equipment and services include those designed, developed, manufactured, or supplied by entities listed below or persons affiliated with their ownership or control.

6- Evaluation and Award

- 4. ROP-ABADEI reserves the right to reject any or all bids without assigning any reasons.
- 5. ROP-ABADEI reserves the right to waive any administrative requirement in this RFQ.
- 6. If the Offeror anticipates subcontracting any of the work to a subcontractor, the Offeror must provide details of the subcontractor to ROP-ABADEI for approval.
