## 1. MOBILIZATION

The work shall consist of mobilizing equipment, supplies and securing bonds and permits necessary to do the work as stated in the contract and/or agreement and demobilization of excess materials and equipment from the work site.

## 2. SUPERVISION AND MONITORING

IRW will designate one of staffs to coordinate with the contractor to carry out regular monitoring of the Tube Wells. IRW will undertake on-the spot checks, supervising and monitoring of the progress and quality of the work.

It is imperative that the contractor informs IRW on the milestones of the project so that together with the contractor IRW conduct the monitoring of the work.

The contractor will always collaborate with IRW field monitoring officer so as to be guided by the technical specification, and the scope of works to be carried out.

## **3.** RESPONSIBILITY OF THE CONTRACTOR

- The contractor will have to start his agreed activities, deliver his necessary machinery, tools, material, Tube Wells, staff and equipment in the Chemtal, Deh dadi and Nahr Shahi, as per the agreed implementation plan and aware of the accessibility constraints.
- The work contractor shall fill the 3 following documents which are to complete the parts of this file:
  - Work contractor form for A work contract
  - Work Contractor's Declaration (S) Including the Financial Identification and AISA Registration offer.
  - Contractor should have prior familiarity of the targeted district.
- Besides this they will provide an additional and official pro forma and the technical specifications of all the items proposed.
- Supplier will be responsible for the repair and maintenance of tube wells after 6 months of hand over.
- The purchase of all the material would be submitted to a work contract (approvals), under authority of IRW.
- The Contractor according to the agreed schedule will present real expenses and the quotation amount has to be presented in only Afghani.
- The Contractor should be ready to start the works as agreed with IRW after the notification of call for negotiated procedure results.
- It is up to the Contractor to arrange at his own expenses the necessary mobilization of the required staff and stock of materials installation on site for the defined work. The contractor will manage with his means for the supply of adequate and necessary materials, equipment and labor to the working site.
- A Good coordination between IRW and the Contractor will have to be done through regular field visits and coordination meetings being arranged by the Logistics department if IRW Afghanistan.
- The work has to be realized in good co-operation with the mention village CBPM Committees that will be responsible of the Operation and Maintenance of the tube wells of the project after being handed over by IRW.

- The CBPM Committees are hereby authorized to monitor the works of the contractor and report to IRW Field staff for any dissatisfaction of works or materials being used at site.
- The contractor will have to respect a strict agreed execution of the planned works.
- IRW does not take the responsibility of contractor's security in the area It is the responsibility of the contractor. However, the contractor will benefit from IRW's network information. In any case insecurity events that occur, temporary suspension could be considered with prior authorization from IRW's representative.
- It is also under Contractor responsibility to ensure a safety barrier (Fence) around the site and to prevent any incident with the communities around it.
- The Contractor will be responsible for the security of his equipment and staff on the Tube well sites and IRW will not be at any case responsible of any degradation or theft of material and equipment or harm to contractors' staff. It is up to the contractor to ensure adequate security measures are in place usually security guards.
- If it appears during the course of the work, that the contractor cannot fulfill his obligations within the agreed, he will have to installation his means in order to complete the work within the completion period.
- The contractor will be fully responsible for cleaning and removing of all the materials and equipment after the completion of the work. A clean place will have to be set up as it belongs to the community area.
- A visit of conformity of the materials will be carried out by IRW staff at the beginning of works, with an aim of notifying.
- Conformity with the material as proposed in the offer.
- Compatibility between the capacities of this material, technical specification of this document and completion periods#
- If the supplier fails in any way to complete the task or any deficiency is noticed in the quality of work 10% penalty from the whole contract will be deducted.
- The 2% government tax will be deducted from the final payment as per the government tax law.

#### ✓ Concrete Material

#### Cement:

- ✓ Recoveries of cement dust will be prohibited.
- ✓ Cement use on the site should not be stored over long periods (more than two weeks) the engineer on site will check the quality on regular basis.

#### Sand:

- ✓ Sand calibration
- ✓ The sand used to prepare the mortar must be washed to avoid any soil particles being available to the site.
- ✓ Fine sand for tube well

#### **Gravel:**

✓ The gravel used for civil works (concrete) must be crashed, cleaned and have a 1 to 3cm diameter.

#### Water:

✓ The water used for every concerts works needs to be clear from salt, clay and other chemical materials

#### IRA SELECTION CRITERIA:

Tenderers In the event of achieving a fail to each one or more of the below Selection Criteria in this part will be excluded from participating in this Competition.

- 1- The goods contract will be awarded on the basis of the 'best value for money 'and in accordance with the fulfillment of following criteria:
- 2- The tenderer must provide 10% bank guarantee of their total tender value. The guarantee letter must be valid for duration of 2 months commencing from the start date of the tender, the bank guarantee should be specifically mentioned the project name and reference number, this guarantee will be kept for the contract duration for the awarded bidder.
- 3- Tenderer must declare that they satisfy the financial and economic requirements by providing the bank statements of their company presenting 75% of their tender total value currently available, the statement should not be older than 3 months.
- 4- The documents should include a copy of company's valid license.
- 5- The venders shall be required to attach the evidence of their past related experience containing at least two commercial references. The particular criteria weighting shall be in favour of those suppliers providing the relevant experience with international NGOs.
- 6- All tenders must complete the pricing according to the table.
