The Aga Khan Health Services – Afghanistan herein referred to as “Client” invites sealed bids (technical & price bids in one envelope) from eligible bidders for the procurement of Construction of FHH Clinics in Baghlan and Badakhshan Provinces in three (3) lots.

National Competitive Bidding (NCB) will be conducted in accordance with AKHS-A Single-Stage One-Envelope Bidding Procedure and is open to all Bidders who have experience relevant to this procurement, the specifications, delivery requirements, and other terms and conditions are reflected in the Bidding Documents.

3	Liquidated Assets (Availability of Cash)	The amount of such cash shall not be less than AFN 19,000,000/- or equivalent to USD.

2	Execution of One Similar contract	Bidders must provide evidence of having executed at least One Single Contract of similar nature (Construction) within the any of the last 5 years (2019 - 2023) the amount of such contract shall not be less than AFN 58,000,000/- or equivalent to USD.
3	Liquidated Assets (Availability of Cash)	The amount of such cash shall not be less than AFN 20,000,000/- or equivalent in USD.

Should any of the information data submitted by the bidder in the documents be unclear and not substantiated by supporting documents, such information shall not be considered for evaluation.

- b) Bidders are required to submit bids in person or courier on or before on or before the deadline: **19-May-2024 at 10:00 AM**, together with Bid Securities in the amounts.
