- The bidder must provide similar contract copies.
- Sub-Contracting is not applicable.

## **Tax:**

Pursuant to Article 72 in the Afghanistan Tax Law effective March 21, 2009, PARSA is required to withhold "contractor" taxes from the gross amounts payable to all Afghan for-profit subcontractors/vendors. In accordance with this requirement, PARSA shall withhold two percent (2%) tax from all gross invoices to Afghan subcontractors/vendors under this Agreement with active License of Ministry of Commerce.

For subcontractors/vendors without an active License Ministry of Commerce, PARSA shall withhold seven percent (7%) "Contractor" taxes per current Afghanistan Tax Law.
